20 I, Dianne York-Goldman, hereby declare as follows:

21 1. I witnessed the deposition of Ms. Teri Thomas on August 28, 2008. Ms. Thomas has  
22 to be one of the most intelligent and capable employees employed at the Fay Avenue Properties  
23 building. Therefore, I was surprised at her deposition to witness that Ms. Thomas could not  
24 remember or recall most of the details of her duties that she would know firsthand working at the  
25 La Jolla Spa MD every day.

1           2. Pursuant to Ms. Thomas's deposition, she is the executive assistant to Mitchel  
2 Goldman. Ms. Thomas opened up a private post office Box next door to the La Jolla Spa MD at  
3 the UPS Store for Mitchel Goldman. According to Ms. Thomas's testimony, she makes all  
4 invoices payable to the private post office box instead of requesting that payments are sent to the  
5 La Jolla Spa MD facility. Therefore, all checks payable to the La Jolla Spa MD are being routed  
6 to Mitchel Goldman's personal post office box.

8           3. In her deposition, Ms. Thomas admitted that there was a wire transfer this year from  
9 the Lumenis Laser Company in an amount between thirty to fifty thousand dollars (\$30,000.00 to  
10 \$50,000.00). This money transfer was used for a trip to China for Mitchel Goldman. This trip  
11 took Mitchel Goldman away from the company business for approximately one week. Although  
12 Ms. Thomas was the person primarily responsible for this wire transfer, she could not remember  
13 how much the wire transfer amount was for more which bank account the wire transfer was sent  
14 to.

16           4. It appears that a large amount of Ms. Thomas's testimony contains holes in  
17 information that she would be privy to on a daily basis. Moreover, as Mitchel Goldman's  
18 executive assistant, Ms. Thomas redirected finances belonging to the La Jolla Spa MD to a  
19 private post office box as a regular practice.

21           5. I respectfully request that the court review the rough transcript of Teri Lynn Thomas  
22 attached hereto as Exhibit "A."

24           I declare under the penalty of perjury under the laws of the State of California that the
